



# God loves justice.\* Do you?

Are you looking for a summer internship opportunity that will allow you to grow spiritually and develop professionally even as you pursue justice for victims of sex trafficking and commercial sexual exploitation? Then we hope you will apply for the 2010 p.u.r.e.JUSTICE internship program, hosted by the National Coalition for the Protection of Children & Families.



This eight-week summer internship based in Cincinnati, OH is designed to train undergraduate students in embracing a justice lifestyle while providing them with the opportunity to protect the vulnerable from sex trafficking and commercial sexual exploitation through the development of educational materials, awareness campaigns, and strategic partnerships. The internship may be particularly attractive to students contemplating careers in law, social work, communications, criminal justice, or missions.

## Eligibility

Candidates must be between 18 and 23 years of age and, at the time of application, enrolled in an undergraduate degree program at a college or university. Candidates also must be in agreement with the Apostles' Creed and possess a mature Christian faith.

## Program Details

**Training:** Interns will participate in training designed to introduce them to the National Coalition's history and strategies and learn about the evil of commercial sexual exploitation.

**Outreach:** Interns will be given public speaking opportunities to educate the public about the issues of sex trafficking and commercial sexual exploitation, and will participate in organizing events to raise awareness about the reality of those injustices.

**Professional and Spiritual Development:** Interns will attend meetings with public officials, academics, clergy, and other professionals on topics such as spiritual growth, social activism, leadership, education/career planning, and public speaking.



## Compensation

Interns will be paid \$10/hour. Travel, lodging, and meal expenses will be covered for work-related trips.

## Application Process

Applicants should submit a cover letter, a statement of faith (may be incorporated into cover letter), résumé (including current GPA), and two recommendation letters to Noel Bouché at [noel@nationalcoalition.org](mailto:noel@nationalcoalition.org) or 800 Compton Road, Suite 9224, Cincinnati, OH, 45231, **no later than March 19, 2010**. Your cover letter should describe your interest in anti-trafficking work, your relevant skills, and how you believe an internship with the National Coalition would advance your personal and professional development. One recommendation letter should come from a personal reference, the other from a professional/academic reference; contact information for your references should be included.
