



Dear Donors,


When I stepped into my role as Chief Financial Officer for the Catholic Diocese of Salt

Lake City in January 2021, I was eager to get to know the workings of the Catholic Foundation of Utah. What I found is a remarkable testament to the generosity that exists in our diocese. Thank you to all of the donors who have put their faith into action by giving through the Foundation over the years.

The state of the Catholic Foundation of Utah is strong. In partnership with our investment advisors, our Investment Committee trustees, and the full CFU board, the Foundation is well stewarded and continues to grow.

The investment portfolio has been constructed in a way to mitigate the impact of the markets. I would be remiss if I didn't acknowledge the market performance impact on the endowments. The Catholic Foundation was not immune to the volatility of the stock and bond markets. We saw an

From my vantage point as CFO, I see your gifts at work in our Diocese every day. It's my privilege to oversee the financial assets that will serve our diocese well into the future.



As you read through the details, you will see that the financial report shows the Foundation has grown significantly. Over the last 5 years, the corpus grew by 11.3% and the number of endowments increased by 10.8%. The most significant growth lies in the distributions offered during that same time period. The distributions offered have increased by 49.8%.

It is truly an honor to serve the Catholic Foundation of Utah. In keeping with the mission of the Foundation, to provide financial support to Catholic entities throughout our Diocese, I am grateful for the heartfelt giving amongst us.



DONOR PROFILES

Chuck Dover

Chuck Dover is a force of nature. When he enters a room, a palpable sense of purpose follows. Sharply focused on giving presence to every moment, Chuck embraces every opportunity to serve and inspires others to join him. A storyteller and a virtual vat of historical knowledge, religious and otherwise, Chuck shares nuggets of wisdom with effortless grace. Most of all, he lives each day with faith and gratitude. That simple model of service, faith and gratitude is the essence of Catholic stewardship, and in Chuck's case, it comes with a beautiful megaphone attached. Chuck not only has the gift of guiding others to philanthropy, but he is also blessed with a magnificent, singing voice.

A product of a kindergarten through 12th grade Catholic education, Chuck graduated from Judge Memorial in 1969. As a Knight of Columbus, he readily embraced the call to serve. During his four decades and two years as a Knight, Chuck has had ample opportunity to support Catholic causes and encourage others to join him along the way.

Chuck was recently recognized as Knight of the Year for 2022. Last year, Chuck worked to create his second academic endowment, to support Knights of Columbus families with members studying in higher education or trade school. For Chuck and his fellow Knights, the four degrees of the Knights of Columbus—Charity, Unity, Fraternity, and Patriotism engender a spirit of giving that lifts Catholic communities in perpetuity.

Chuck's outlook on philanthropy was buoyed by an analogy from a speech heard many years ago.


A raindrop falls alone, but as they collect, they grow into streams, lakes, and oceans.

Robert and Cece Holt

Bob and Cece Holt arrived in Salt Lake City in 1975 and quickly settled into the pews at the Cathedral of the Madeleine. Msgr. Bircumshaw was newly ordained. Main Street in Salt Lake City was undergoing a beautification project. Bob was in law school at the University of Utah, and he and Cece hoped to find connections that would root them to life in Salt Lake City.

After attending their first Mass at the Cathedral, Bob and Cece made their exit at the conclusion, to head home. But as Cece recalls, they didn't get far. Flagged down by parishioner Larry Brennan, they were eagerly invited to come back inside and join coffee hour in the Cathedral's basement.

As time went on, the Holts found not just their spiritual center, but a caring, inter-generational community they could call home. Cece fondly remembers those early years. "There was a closely fostered connection between priest and parish. We were friends with 80-year-olds!" she says with a smile.

Cece and Bob fell comfortably into parish life and Utah living. As their family grew, Bob and Cece were able to send their four children to Cosgriff and later, Judge Memorial Catholic Schools. They were grateful to receive Msgr. Vaughn Scholarships for their children's education along the way. Cece remembers, "Bob and I were so grateful, and he always said that one day, we would give back."

True to their intention, Bob and Cece did give back. They served in the parish youth group ministry, and later as part of the Cathedral Vocations Team. They traveled around the Diocese championing Catholic ministries and encouraging others to get involved.

Bob was a helicopter pilot with the Utah Army National Guard, and retired as an administrative law judge. Cece taught at Cosgriff and Judge Memorial. Cece has served on the board of the Catholic Foundation of Utah for many years and will be stepping down this March. Her work there has been a testament to the benefits of looking to the future, to ensure that the church continues to stand strong.

In December 2021, Bob and Cece established *The Robert and* Cece Holt Endowment for the Cathedral of the Madeleine. The endowment's purpose is to provide financial support to the Cathedral for specific projects, improvements, or parish needs.



V.J. and Loretta Simonelli

"January 21, 1941, was the day of my birth. It was also the day I became an orphan. I was born in Rhode Island and immediately placed at St. Aloysius Home, a Catholic orphanage. In those days, there weren't many foster homes that would take in an orphan, so this Catholic orphanage was home to many girls and boys. It would be my home for the next eighteen years."

So begins the story of V.J. Simonelli. He is a testament to the fact that humble beginnings do not define a life, nor do they limit the possibilities for creating a great one. With determination, hard work, and faith in God your life can be bountiful.

V.J Simonelli grew up in that orphanage, which had separate dormitories on each floor for boys and girls. He shared a large bedroom with 23 other boys, and the children attended the grammar school adjacent to the home. V.J. went on to the local high school, where, upon completion of 12th grade he was faced with another stark reality. He and others who had come of age, had to leave the orphanage and start life on their own.

V.J. decided to join the United States Coast Guard. He served his country, then settled down in Rhode Island where he joined the local Police Department. He met and married his wife Loretta, and they raised their three boys.

Over the years V.J. continued to serve. He became an EMT and then an Emergency Cardiac Technician. He graduated a Certified Paramedical Instructor from Connecticut University and was appointed Emergency Medical Service

Training Director of his local community. He taught prehospital care at the Community College of Rhode Island. He became a scuba and diving instructor. He attended trade school and opened his own family construction company. He was a local volunteer Fire Fighter and Rescue Captain for over 20 years. V.J. is not one to let moments go wasted.

After relocating to Utah, V.J. and his family joined St. Francis Xavier Parish. He sang in the choir and served as Maintenance Director for both the parish and school. A Grand Knight in three states, V.J. was appointed Knights of Columbus District Master for Utah, where he served for two years.

Service and faith have always been the guideposts in V.J.'s life. When asked how he managed to do so much, he answers simply, that his faith in God got him through the ups and downs. V.J. believes deeply in living in your best imitation of Christ. "We all need to give back to God, what God has given us. We all need to be Christ like."


UTAH CATHOLIC HIGH SCHOOLS

St. Joseph CHS Seniors Recognized for AP Scores

St. Joseph Catholic High School seniors Mercedes Randhahn and Fernando Ruiz have been recognized for excelling in academics.

Mercedes was one of 306 students worldwide who earned a perfect score in the AP Research exam when scored by their academic paper, presentation and oral defense. About 29,000 students took the AP exam.

"I'm very excited about it," she said of the recognition.

A National Merit scholar semi-finalist, Mercedes is what is known as a "lifer" at St. Joseph's, meaning that she has gone through elementary and high school at St. Joseph Catholic Schools.

She is also an AP Scholar with Distinction and will receive the AP Capstone diploma for successfully completing 11 AP courses during her high school career.

This is not the first recognition she has received. In 2019 she was named Utahn of the Year by Salt Lake Tribune readers for a science project she did on opioids.

Science has always been a passion for Mercedes, who has also taken top awards at the diocesan science fair and the University of Utah Science & Engineering Fair. In May she took second place in the Translational Medical Science category at the International Science and Engineering Fair.

She is planning to apply to several universities with advanced biochemistry programs. She hopes to pursue a PhD in biochemistry and then complete a law degree.

"I want to use my research background to advocate for implementation of various scientific discoveries in terms of health care reform," she said. "Everything that I have been doing has been in order to create solutions for people that don't have opportunities to access health care," she said.

Mercedes also is active in the community. In January she founded the Ogden Youth Association, a nonprofit that hosts a variety of events aimed at "impacting the community in a positive manner, to potentially help people understand that the mountains of Ogden are a great resource," she said.

She also initiated a movement to have a flag designed for Ogden City and is in the process of completing her pilot's license.

Mercedes attributed much of her success to SJCHS Principal Clay Jones; Kari Lane, the school's alumni/enrollment/marketing manager; and chemistry teacher Kory Ulle.

"They have been most influential in my success and my aptitude as a student, because they push my limits and have allowed me to attend courses at Weber State University and supplement my education elsewhere," she said.

Her classmate Fernando Ruiz spent several years attending schools in Okinawa, Japan where his father, an Air Force master sergeant, was stationed before moving to Utah when Fernando was in eighth grade. He has been attending St. Joseph Catholic High School ever since.

Fernando recently received the AP College Board National Hispanic Recognition Award. He was one of 7,000 Hispanic students who scored in the highest percentile in the PSAT/NMSQT among 250,000 high school juniors who took the exam last year.

"It's good to know that all the late nights, the boring class periods – that that wasn't in vain," he said. "This opens up the way for better college acceptance rates for me, as well as other scholarships."

Fernando hopes to major in chemical engineering at a college such as Texas A&M, the University of Utah or Colorado School of Mines. He would like to pursue a career in firearms engineering or automobile engineering.

"There's a lot of people that helped me along the way; they pushed me," he said. "I had a lot of my friends, a lot of my teachers, especially my family and my girlfriend – they have all been a really big help, helping me through the stressful times and the workload."

"Mercedes and Fernando's accomplishments are examples of what all of our students strive for when taking AP courses," SJCHS Principal Clay Jones said. "With the support of their teachers, these two students are excelling in all that they do here at St. Joseph Catholic High School."



Juan Diego Catholic High School isn't just about academics. Part of the 57-acre Skaggs Catholic Center in Draper, Juan Diego Catholic High School is a five-time Best of State winner, a 2019 National Blue Ribbon School of Excellence by the US Department of Education and ranked by the Washington Post as one of the most challenging high school programs. It's no secret that Juan Diego Catholic High School places an emphasis on academics and the success of its students. However, JDCHS's mission is to develop the whole person by serving God, while providing a challenging academic education rooted in Catholic values. Faculty and staff believe in the importance of seeing, hearing, and encouraging students throughout the day, as well as instilling the school's motto, "Spiritus Donorum," spirit of giving.

As an educational leader in blended learning, Juan Diego is expanding its campus to include several innovative science and engineering spaces. These state-of-the-art facilities include a virtual reality lab, eight new cutting-edge science labs and classrooms, an engineering lab, four collaborative classrooms, and a newly renovated computer lab. This will give students more opportunities to learn STEM subjects in an interactive setting. Continuing Juan Diego's long-standing partnership with Arizona State University, a virtual reality lab is under construction and

will revolutionize how our students learn. With this new technology, teachers can conduct virtual reality lessons in which students interact with the content in focused, virtual environments.

A newly developed engineering space, when combined with specific engineering coursework, will provide students with opportunities to explore design thinking, problemsolving, technology, and creative skill sets. The lab offers a space for students to work on group projects and build prototypes. These opportunities are key to developing the skills required to become successful engineers in the future.

Positioned in the urban heart of Utah's capital city, Judge Memorial Catholic High School embraces the charism of Cura Personalis, which means to take a holistic approach to invest in students' intellectual, social, physical and spiritual development, so they can thrive as citizens of the world. As the school honors its 100-year history, it also looks ahead to lay the foundation for the next 100 years.

Founded by immigrants-turned-entrepreneurs, Judge Memorial combines Catholic faith tradition with 21st-century innovation, to foster a vibrant student community dedicated to scholarship, service and spiritual growth. The threads of Judge Memorial's past and present are inextricably linked, empowering the vision for the school's future.

The footprint for the current school building was originally Judge Mercy Home, a hospital established for coal miners working in Park City and founded by immigrants-turned-Silver King Mine magnates John and Mary Judge. As the need for a hospital dedicated to the care of black lung patients subsided, Mary Judge worked with the Catholic Diocese of Salt Lake to convert the facility into a school. Mary Judge, considered a pioneering entrepreneur of the era, passed away just before what is now Judge Memorial opened in 1921.

In 1964, Bishop Joseph Lennox Federal brought in the Oblates of Saint Francis de Sales to run Judge Memorial as an all-boys school, while girls could attend St. Mary of the Wasatch Academy. Finally, in 1970, St. Mary closed and girls once again joined the boys at Judge.

Over the last century, Judge has fostered, sustained, and cemented an engine of excellence in education. Judge is the only school in Utah to win the prestigious Blue Ribbon award more than once — earning the designation four times.

For 100 years, Judge has built a proud legacy of preparing students for college and making a meaningful mark on the world. The school remains dedicated to offering a rigorous curriculum and supportive environment, while ensuring that the doors are open to students of all backgrounds.

With the present-day guidance of a committed administration, faculty and staff, the school continues to build upon the legacy of Catholic education started by Mary Judge. As Judge Memorial embarks on its second century, the institution remains invested in Cura Personalis and empowering Builders of a More Just Society.

My Journey to the Priesthood

Father Tristan Dillon, Parochial Vicar of Saint George Catholic Church, Shares His Story

My name is Fr. Tristan Dillon, and I am the most recently ordained priest for the Diocese of Salt Lake City. While I am now a proud Utahn, I was born in Seattle, Washington—a true child of the Pacific Northwest, raised drinking coffee after mass from a young age. When I was 16 my father got a job in St. George, Utah, so my family packed all of our things and moved.

After arriving in Utah, I began to volunteer at the local parish and spend time praying before Christ in Adoration, discerning why God had called me to Utah. It was here that I began to discern my vocation with a simple prayer, "Lord, what am I supposed to do with my life"? As I made this prayer, I eventually felt drawn to the priesthood.



I realized that I wanted to give my life to Jesus Christ in a crazy and radical fashion, and I wanted to be able to serve the people of God.

I began to meet with the parish priest for spiritual direction and he shipped me off to Salt Lake City to meet with the Vocations Office and the Bishop. I was accepted to the diocese and sent to Mount Angel Seminary in Oregon in the fall of 2013 to begin my journey. Four years

later, I graduated from the college program with a degree in Philosophy and Literature. After college, I continued at Mount Angel for my theological studies. In April of 2022, I graduated from the seminary with two masters degrees in Theology and Divinity, plus a Sacred Theological Baccalaureate from the Anselmo in Rome. Then the best thing happened, I was ordained a priest on the Feast of the Sacred Heart of Jesus on June 24, 2022.

It is through the donations of the faithful of Utah that I was able to discern the priesthood without having to worry about the financial cost.

It is odd to sum up over a decade of my life so quickly. My discernment and journey toward the priesthood has been filled with many incredible memories and countless wonderful people. I grew up in a poor family, so the thought of going to college was outside of the realm of possibilities without incurring incredible financial debt. I was blessed to learn that the Diocese of Salt Lake City takes on the financial burden of seminary education. It is through the donations of the faithful of Utah that I was able to discern the priesthood without having to worry about the financial cost, rather I could fully give myself to discern the will of God for my life. I am truly blessed by the support, and I cannot thank you enough for your support to both the CFU and the DDD.



THE PILLARS

Pillars supporting the future of the Catholic Diocese of Utah

Pillar One | The Bishop's Future Fund

The Catholic Church in Utah has grown dramatically in the last two decades. New facilities and substantial upgrades were completed in several urban and rural areas. The continuing escalation of property costs hastens the need to plan now, for future expansion. Prudent land purchases now, in areas where population growth will require new churches and schools, will save the Church money later. The Bishop's Future Fund will be used to:

- Buy land for future parish and mission communities
- Build new churches, schools, and facilities
- Expand and renovate already existing structure



Pillar Two | Funding for Youth Ministry and Catholic Schools

The Youth Ministry and Education Endowment exists to support programs which will protect and nurture our children. It will provide monies for catechetical materials and religious education. Finally, by providing an additional subsidy, it attempts to drive a significant wedge between rising costs of education and the need to provide a just and fair salary for our teachers.



Pillar Three | Training for the Priesthood

Accelerated growth underscores the need for more well-trained priests and pastors. Preparation for the priesthood is a lengthy process of academic studies, formation in spiritual life, and training in pastoral skills. The cost is in excess of \$40,000 annually for each seminarian. A well-funded Seminarian and Priestly Formation Endowment will make it possible for the Diocesan Vocations Office to carry out an aggressive recruitment effort aimed at encouraging candidates for the priesthood. Further, it will ensure those who do answer the call will be educated and well-trained throughout their lifetime of service to the Church.



Pillar Four | Supporting our Rural Church Communities

In Utah's isolated regions, the challenge for the Church has been to support and maintain the faith of Catholics living there. Work conditions for the priests, deacons and lay evangelizers are daunting. Each month they travel thousands of miles to provide Mass, sacraments, and religious instruction. The costs of gas and car maintenance is significant. Resources among the local people are slim. Endowed gifts donated to the Catholic Rural Missionary Outreach and Development Endowment will be used for:

- Transportation needs including purchase of vehicles
- Purchasing of communications and data processing equipment and software
- Providing catechetical resource materials



Ways to Give

The Catholic Foundation of Utah receives, manages, and administers the following types of endowments:

Permanent Endowments – Gifts designated to be permanently invested. Only the appreciation income is available and is distributed annually to the beneficiary.

Family Named Endowments – Established in recognition of one's own name, a family name, or in memoriam, created with a required initial gift of \$10,000.

Temporarily Restricted Endowments – Allow both the principal of the gift and appreciation on those funds, to be used by the beneficiary organization.




